**Fiscal Year 2024-2025 Budget Ordinance**

**BE IT ORDAINED** by the Board of Commissioners of the Town of Franklinton, North Carolina, meeting in open session this 19<sup>th</sup> day of March 2024 that the following fund revenues and departmental expenditures, together with certain restrictions and authorizations are adopted.

**SECTION 1.** The following revenues are estimated to be available in the General Fund for the Fiscal Year beginning July 1, 2024, and ending June 30, 2025.

**SECTION 2.** The following amounts are hereby appropriated for the operations of the Town government and its activities for the Fiscal Year beginning July 1, 2024 and ending June 30, 2025 in accordance with the chart of amounts heretofore established for the Town of Franklinton General Fund:

**SECTION 3.** Funds appropriated in the Fiscal Year 2023-2024 budget and encumbered on June 30, 2024, shall be authorized as part of the Fiscal Year 2024-2025 budget appropriation by adoption of this budget ordinance.

**SECTION 4.** There is hereby levied a tax rate of seventy-three cents (\$0.73) per one hundred dollars (\$100) of valuation for property listed for taxes as of January 1, 2024, for the purpose of raising the revenue listed as current year Ad Valorem Tax in the General Fund under Section 1 of this ordinance. The revenue neutral rate is calculated at (\$0.3884) per one hundred dollars (\$100) of valuation. The official vehicle tag rate for the Town of Franklinton is \$20 for Fiscal Year 2024-2025

**SECTION 5.** The Budget Officer (Town Manager) and Finance Director are hereby authorized to transfer appropriations within departmental appropriations. The Budget Officer and Finance Director are not authorized to effect transfers between departmental appropriations or funds without the approval of a budget amendment.

**SECTION 6.** Copies of this Budget Ordinance shall be furnished to the Clerk of the Board of Commissioners, the Town Manager, and the Finance Director and kept on file by them for their direction in the execution of their duties.
